AGENT

Requirements and Reward

- \$75,000 of paid premium earns a trip for two (2)
- Minimum of \$50,000 must be paid individual life insurance premium.
- Only Underwritten Medicare Supplement premium counts.

FMO

Requirements and Reward

- \$300,000 of paid premium earns a trip for two (2)
- Minimum of \$200,000 must be paid individual life insurance premium.
- Only Underwritten Medicare Supplement premium counts.

Achieve the stated production requirements by June 30, 2019, and you can join us THIS YEAR at the Paradisus Palma Real in Punta Cana (or on the fishing trip in Canada).

Trip Dates:

- Punta Cana – November 9 through 13 or 13 through 17
- Canadian Fishing Trip – September 7 through 11 or 11 through 15

Please note: Trips earned by June 30, 2019, and used on a 2019 trip cannot also be used on a 2020 trip. However, you will be able to earn a trip for 2020 based on production from July 1 through December 31.

The Rules

The writing agent and/or FMO must be contracted and actively representing Pekin Life Insurance Company at the time of the trip. The trip is available to the agent and qualifying guest, which is defined as a spouse or significant other. All attendees must be at least 21 years of age as this is an adult-only trip. The trip may be used by any actively licensed agency employee. Agent is responsible for taxes and will receive a 1099 for the value of the trip. Qualifying business must be issued and paid for between January 1, 2019, and December 31, 2019. Any lapse on business written within the prior 13 months will be charged against the agent's current year production. The trip is an all-expenses-paid event including all food and beverage, accommodations, and activities as to be determined. Transportation to and from the trip is not included. Pekin Life Insurance Company reserves the right to modify or change any aspect of the trip at its sole discretion. All decisions are final.
